# DISC DOG TRIAL CLASSES OFFERED

## Official Classes

**Retrieval Proficiency Test (RPT)** – This test shows that a dog is able to retrieve an object from a minimum 10 yards away under the handler's control. The handler may use any object for the test (disc, ball, toy, etc.). The object must be delivered to the handler in a reasonably straight line and within the outlined box the handler stands in. To have their competition scores recorded with the CDDA, a dog must pass the RPT. Dogs must be at least 16 weeks of age or older to do the RPT.

Dogs must be at least 12 months of age to compete in CDDA sanctioned classes. If your dog is not successful with achieving their RPT in the first trial, they are still able to qualify in the other 2 trials.

**Single Disc** – In two one-minute rounds, the dog and handler team must complete as many successful throws and catches as possible. Dogs receive points for the distance where the disc is caught. Bonus points are given if the dog gets air (all 4 feet leave the ground). Official Fastback discs supplied by the host club for each trial must be used.

Points are earned as follows:

### Novice Single Disc:

Catches over 10 yards earn 1 point  
Catches over 15 yards earn 3 points  
Catches over 20 yards earn 5 points  
Catches with dogs all four feet off the ground earn 1 extra point per catch.

### Advanced Single Disc:

Catches over 30 yards earn 7 points

Mini division is for dogs measuring 15" and under.

**Freestyle** – In a 90 second routine to the music of their choice, a dog and handler team performs tricks and disc catches. Teams are judged on the number of catches, difficulty of tricks, artistic impression and compulsory moves. Up to 5 discs may be used. Compulsory moves are as follows:

Over the body catches  
Under the body catches  
Crossovers in front or behind

Multiples of 3 catches or more  
Long throws

Handlers must supply their music on CD the morning of the trial.

**Furthest Catch** – Teams get three throws to make their longest catch. Only the official Fastback discs supplied by the host club, must be used. Longest catch awards are as follows:

Catches over 100 feet: Bronze Award  
Catches over 150 feet: Silver Award  
Catches over 200 feet: Gold Award

**Junior Handler**- in the Junior class catches are scored the same as Novice. Junior Handlers must register with CDDA and do not have to own the registered CDDA dog they throw for. You must be 14 years old or younger to compete as a junior handler. Registration forms for junior handlers can be found on the website listed below.

Reminder: \*\* Your dog must have a CDDA competition number before entering trials. Please make sure to send in your application at least 3 weeks prior to entering for any CDDA trial\*\*

All dog and handler teams that compete in the Single Disc classes will receive an official Fastback Disc. These discs must be used in all official competition rounds except freestyle and RPT classes. Discs will also be available for sale at the trial.

The Retrieval Proficiency Test will be a one time fee for these trials, with three chances to achieve a passing mark. If you do not pass on Saturday AM, you can try again on Saturday PM or Sunday AM. Any points that are achieved will not count towards CDDA titling without a passing RPT.

Check in times will be from 7:15AM-7:45AM each day and first dog on the line is scheduled for 8:00AM, weather permitting.

A food vendor will be on site.

Fees must accompany entries-no post dated cheques please. Entries must be received by Monday August 2, 2010. Please make sure that you include your signed release form, entry form and payment. Send entries to:

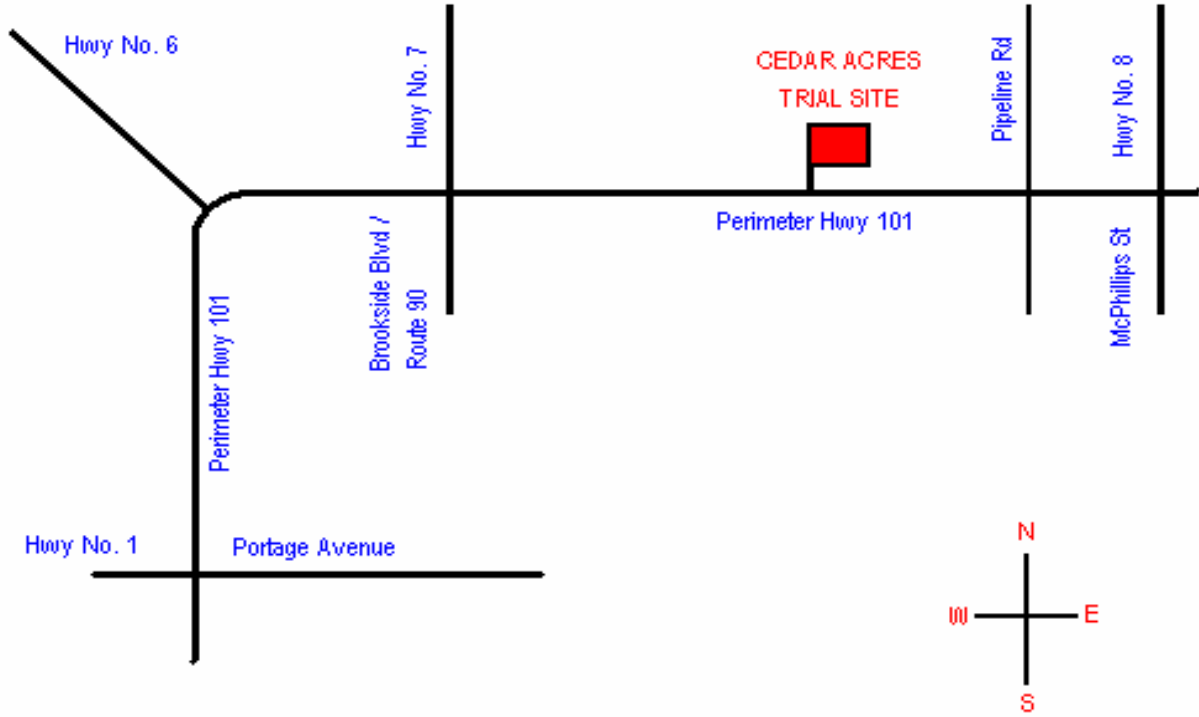
## COMPETITORS INFORMATION

- 🐾 Trial is open to all dogs being at least 12 months of age, including purebred and non purebred.
- 🐾 No aggressive dogs will be allowed at the trial. At the discretion of the judge or 'PCDD, we reserve the right to request that a dog be removed if acting aggressively.
- 🐾 All owners must ensure that they pickup after their dogs. Failing to do so may result in being asked to leave the trial with no refunds of any kind.
- 🐾 There will be designated bathroom areas for dogs. Please respect the owner's property and only potty your dogs in these areas. Failing to pick up after your dog may result in being asked to leave the trial with no refunds of any kind.
- 🐾 'PCDD reserves the right to remove any dog that is visibly hurt or if under heat stress.
- 🐾 ALL dogs must be on leash when not competing.
- 🐾 Refunds will be given for bitches that come into season after the closing date or for an injured dog, provided a veterinarian certificate is submitted. All refunds, regardless of the reason, will be processed after the completion of the trial.
- 🐾 The judge has the right to disqualify an entrant for any reason that s/he feels is warranted. All disqualified exhibitors will forfeit their entry fees.
- 🐾 All owners or handlers are fully responsible for all dogs that they are in possession with at these trials.
- 🐾 Only official Fastback discs will be allowed to be used when competing in sanctioned trials.
- 🐾 There will be no overnight camping at the trial premises.
- 🐾 Tents, kennels, x-pens, may be left overnight at the owner's own risk.
- 🐾 Move ups will be accepted for those teams who complete their BDD Saturday. A move up form must be submitted at end of either trial on Saturday.
- 🐾 No abusive or unsportsmanlike behavior towards a dog or any person will be tolerated at these trials. In the event of any such behavior, they will be asked to leave with no refunds of any type.
- 🐾 Dogs should never be left unattended unless in kenneling area. Dogs are not to be tied to an obstacle, permanent or temporary anywhere on the trial site.
- 🐾 No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, acts of God, public emergency and act of a public enemy, or any other cause beyond the control of the organizing committee.
- 🐾 This event is held outdoors on grass. Bring your own tent, shade, kenneling and lawn chairs.
- 🐾 A food canteen will be on site.
- 🐾 Dogs MUST be registered with a CDDA number before trialing.
- 🐾 No practicing will be allowed anywhere near the competition area.
- 🐾 Handler/owner agrees to abide by all rules and regulations of the CDDA and 'PCDD. Failing to do so will result in dismissal.
- 🐾 These events are held on private property. Respect to the owners and surrounding community will be first priority.
- 🐾 Most of all have a great time!!!!
